

THE ACTIVITIES INCLUDED FORMING FARMER ASSOCIATIONS, ESTABLISHING HOME GARDENS FOR HOUSEHOLD NUTRITION AND POST-HARVEST LOSS PREVENTION AND TRAINING. THE IMPACT ACHIEVED FROM THESE LIVELIHOODS ACTIVITIES WAS A 43% INCOME INCREASE FROM CROP ACTIVITIES COMPARED TO A NON-INTERVENTION GROUP.
