THE INTERVENTION INCLUDED OFFERING 539 FARMERS ACCESS TO CROP PRODUCTION INPUT LOANS, EXTENSION AND TRAINING FOR IMPROVED CROP PRODUCTION. ACTIVITIES FURTHER INCLUDED FORMING FARMER ASSOCIATIONS, INTRODUCING SAVINGS GROUPS, PROVIDING DIGITAL FINANCIAL INCLUSION, AND OFFERING GROUP-BASED RAM FATTENING FOR INCOME GENERATION. EARLY IMPACT ASSESSMENTS DETERMINED THAT LIVELIHOODS ACTIVITIES INCREASED INCOME BY 43% COMPARED TO A NON-INTERVENTION GROUP.
