INTERNATIONAL DEVELOPMENT-NURU INTERNATIONAL STARTED INTERNATIONAL PROGRAM OPERATIONS IN KENYA IN 2008, FOCUSING ON FIVE PROGRAM AREAS: AGRICULTURE, WATER AND SANITATION, COMMUNITY ECONOMIC DEVELOPMENT, EDUCATION AND HEALTH CARE. BY THE END OF 2010, 10,000 PEOPLE WERE SERVED BY THE PROGRAM. THE AGRICULTURE PROGRAM ENROLLED 2,000 FARMERS, GIVING THEM ACCESS TO TRAINING, RESOURCES, AND QUALITY INPUTS. THE COMMUNITY ECONOMIC DEVELOPMENT PROGRAM ADMINISTERED 242 SAVINGS GROUP AND INDIVIDUAL SAVINGS ACCOUNTS, ISSUED 103 LOANS, AND TRAINED 140 COMMUNITY REPRESENTATIVES IN FINANCIAL PLANNING WHO WILL THEN TRAINING THE COMMUNITY. NURU INTERNATIONAL'S U.S. AWARENESS PROGRAM HOSTS EVENTS AND PRESENTATIONS THROUGHOUT THE COUNTRY AS WELL AS PUBLISHING VIDEOS AND EDUCATIONAL INFORMATION THROUGH THE INTERNET AND OTHER MEDIA. THE PROGRAM BUILDS EMPATHY FOR THE POOR BY SHOWING WHAT LIFE IS LIKE WHILE LIVING IN EXTREME POVERTY: CHRONIC HUNGER, CONSTANT SICKNESS AND DISEASE, RAMPANT ILLITERACY, HIGH CHILD MORTALITY, CONTAMINATED WATER, AND NO ACCESS TO THE RESOURCES THAT WILL CHANGE THESE THINGS. DURING 2010 NURU INTERNATIONAL'S AWARENESS PROGRAM LAUNCHED A CAMPAIGN CALLED "BE HOPE TO HER" ON 26 CAMPUSES AND CITY CENTERS THAT INCLUDED OVER 1,500 PARTICIPANTS.
